



<b>Course Title: Temporary Traffic Management Inspection and Audit (7254)</b>	
<b>Duration: 2 Days</b>	<b>Certification: QQI Certification – Level 5</b>
<b>Expiry Period: 5 Years (QQI certification has no expiry date)</b>	<b>Award: Certificate in Temporary Traffic Management - Inspection and Audit (Level 1, 2 and 3 Roads)</b>

**Aim of Programme:**

The aim of this programme is to:

- enable Learners to develop a comprehensive range of skills, specific to inspecting and auditing Temporary Traffic Management at Roadworks
- give Learners a detailed theoretical understanding of the subject. This includes advanced occupational skills, enabling certificate holders to work independently and progress to the full Level 5 Specific Purpose Certificate in TTM Design and Inspection
- train Learners in the principles of Temporary Traffic Management Inspection and Audit in accordance with **Chapter 8 of the Traffic Signs Manual, DoT Temporary Traffic Management Design Guidance Document**, Health and Safety Legislation, Road and Road Traffic Legislation, Case Law and Industry Best Practice

The programme will equip Learners with the:

- knowledge of where to access the relevant information, design standards and guidance material
- know-how and skill to carry out a temporary traffic management inspection
- know-how and skill to carry out a temporary traffic management audit

**Target Learner:**

This training programme is for learners who will have worked with or have experience in Temporary Traffic Management. The primary target grade is Traffic Management Auditors and Inspectors, other grades applicable are Managers, Engineers, Safety Professionals and Technicians

**Learning Outcomes:**

On completion of this programme, the learner will be able to:

- Compare a TTM arrangement on any road level with the required design parameters and criteria and identify non-conformances
- Assess the risk to safety posed by non-conformances in TTM arrangements, categorise them and compile an Audit and Inspection report with recommendations
- Identify the hazards on a roadworks site and assess the effectiveness of the TTM control measures put in place in controlling those hazards
- Examine a TTM Job Information Pack and assess its adequacy in relation to the type of works being carried out
- Be able to carry out TTM inspections and audits to a high standard showing a clear understanding of the role and responsibilities of the TTM inspector and auditor

**Assessment:**

There is **Theory** based examination which is a Classroom Exam

Also, there is a **Project** which is to be submitted within 8 weeks of the classroom training

### **Entry requirements:**

- Applicants must be able to demonstrate a level of knowledge, skill and competence associated with Level 4 of the NFQ
- Must have a level 6 qualification in engineering or safety
- Be able to read, prepare and understand site layout drawings
- Have an understanding of risk assessments and should be able to undertake a quantitative risk assessment of a roadworks site
- Should have a minimum of 7 years post graduate experience, with 5 years experience in road design, road construction, or TTM
- Learners must have access to live roadworks site to carry out an audit and inspection as part of the assessment
- Permission from the host organisation to access the relevant construction stage safety plan for the live roadwork site
